Who is eligible?

VITA (Volunteer Income Tax Assistance) prepares tax returns for those who meet household income requirements of \$56,000 a year or less. We prepare current year tax returns during the tax season. Prior year tax returns and amendments will be completed by appointment after April 15th.



When can I file?

The Goodwill Career Center will be filing tax returns during the tax season from **January 21 - April 15, 2020**. Walk-ins welcome at Columbus Midtown Career Center at 2601 Cross Country Drive. Valet Services available at FOUR different locations January 21 – April 15, 2020. Let Valet work for you while you go to work!



How do I file?

You can file your taxes at one of 4 locations in the 2020 tax season! Meet with an IRS-certified preparer in person for same-day tax preparation in Columbus at the Midtown Career Center. OR Use Valet VITA to have your documents scanned, and then pick up the completed return at a later date at one of 4 locations on the back.

What do I bring?

Please make sure you have the following documents:

- ❑ **PHOTO ID** for taxpayer (and spouse if filing jointly) no photocopies
- ❑ **Social Security Cards** for everyone listed on your tax return, must be the original.
- ❑ **W-2s** for each job held in 2019 for each person in the household. This form reports your name, wage and other tax information to the IRS
- ❑ **1099s** showing other income (unemployment, Social Security, school loans, health care reimbursement, state tax refund, gambling winnings, contract work) reported to the IRS
- ❑ **Bank account numbers** from a voided check, bank or credit union's routing number and savings or checking account number for your refund to be deposited automatically into your account through direct deposit
- ❑ **Last year's tax return** (if you have it)
