



Enrichment Services Program, Inc. will be accepting appointment calls for Energy Assistance for residents aged 65 and older for the following Georgia counties:

Chattahoochee, Clay, Harris, Muscogee, Quitman, Randolph, Stewart, and Talbot

All ADULTS IN THE HOME MUST BE 65 OR OLDER

Appointments will be made by telephone only except for **Muscogee County which will be made via telephone and our website**, until the allotted appointments have been filled. In Muscogee County applicants must bring the required documents to the CARES Station drive through within 10 days of the scheduled appointment date. You will then schedule your phone interview. All applications will be completed over the phone. We must receive the following documentation in order to process your application for payment:

- For all household members that are 18 years old or older - proof of income for the past 30 days
- For all household members that are 18 years old or older - current proof of citizenship or legal immigrant status, state issued picture identification (ID) such as: driver's license, ID card, voter registration card, passport, military ID, etc.
- Proof of Social Security Numbers for each person in the household
- Last/current month's electric and gas/propane bill for the household if applicable
- If receiving SSI, Social Security, Pension, VA Benefits, or Worker's Compensation, the **2021** award letter is required.

Heating assistance pays your primary heating provider. If you have gas and electric, please bring a copy of both bills.

Documents can be submitted at the Neighborhood Service Center in the county in which you reside. In Muscogee County all documents must be submitted at our drive through Community Cares Station located at 1112 Veterans Pkwy.

To qualify, a family's annual income must be less than or equal to 60 percent of the median income for a Georgia family. For a household of one, the income threshold is \$26,474; the income threshold for a household of five is \$59,057.

The appointment lines may close periodically based on the availability of funds.
